- Dr James Lee LLD, LLM, LLB, BArch, BA(Arch Studies), FHKIA, RIBA, RAlA, FHKI Arb, FCI Arb, MAE, MSCL is a Chartered Architect, arbitrator, adjudicator, accredited mediator and a practicing barrister. He is Adjunct Professor of HKU, Chinese University of HK and has delivered talks/lectures on arbitration/mediation in seminars and universities. He is an Authorized Person, Architect (HK, UK, Australia), Asia Pacific EC Architect and of Class 1 PRC Registered Architect Qualification. He is accredited expert of the Academy for Experts and is arbitrator/mediator on various panels in Hong Kong and Mainland China (CIETAC, HKIAC, HKIA/HKIS, Bar Association, Hong Kong Institute of Arbitrators, Mainland Arbitration Commission, etc.). He has sit and is sitting on various government appeal tribunals. His major practice is in construction related disputes. He is the author of "A comparative Study and Case Analysis on the Recognition and Enforcement of Arbitral Awards between the Mainland and Hong Kong" and has published various articles in journals on arbitration both in Hong Kong and Mainland.

After completing his Master Degree in Arbitration and Dispute Resolution (**MA ArbDR**) and the Master in Law (**LLM**) in 2009, Simon continues his Doctorate in Juridical Science (**JSD**) with thesis topic entitled as "**Construction Dispute and Resolution in Hong Kong**". Since 2004, Simon focuses and participates in the sector of construction disputes and has been continually a member of the **HKIA Contract and Dispute Resolution Committee**. He was enlisted in the **HKIA's List of Expert Witness** in 2007. In January, he was admitted as a **Fellow** of **HKI Arb** and as **Accredited Arbitrator** which later being included in the **HKIAC** and the **HKIA's Lists of Arbitrators**, and completed the HKIAC training as **Dispute Resolution Advisor DRAd**. Simon was the founder of the **Hong Kong Construction Arbitration Centre (HKCAC)** and has been holding as president since then. On such capacity, he responded to the Judiciary's Report of Working Group on Mediation in

May 2010, and has organized Construction Mediation Stage One Training and Stage Two Accreditation Programme for construction mediators in 2010. On behalf of the HKIA, Simon reviewed and wrote commentaries on the HKIAC's Proposed Administered Arbitration Rules and the DOJ's Draft Arbitration Bill in 2008. In 2010, he authored the **HKIA's CDRC Handbook** illustrating for architects various dispute resolution prevention and resolution systems in Hong Kong. He continually gives seminars such as to **IET**, **ICE** and **PolyU** and submit articles on the promotion of construction disputes prevention and resolution, construction mediation as well as the benefits of **specialized facilitative mediation model**, and, in association with his continuing profession as an Architect and Authorized Person, provides services as arbitration consultant, arbitrator, mediator, and expert witness.

He has very active practice in mediation, in particular in the area of construction related dispute.
