Ir Blake, OBE, JP is currently the Chief Officer of Kowloon-Canton Railway Corporation, previously Chief Executive Officer from 2006 and responsible from 1997 to lead its Capital Works Group. He was also the Secretary for Works for Hong Kong Government's overall Airport Core Programme, the Public Works Infrastructure Programme, and the harbour extension of the Hong Kong Convention and Exhibition Centre and North District Hospital.
- Ir Blake is also the former President of Hong Kong Institution of Engineers (1991) and the Federation of Engineering Institutions of South East Asia Pacific (1991). He was the Gold Medal Awardee of UK Institution of Civil Engineers in 1997.

Ir To is the Executive Director of the Construction Industry Council and was previously Secretary General of the Hong Kong International Arbitration Centre. He holds Adjunct Professorships from a variety of academic institutions and is involved with educational reform and governance of such institutions. He is a member of various learned societies and actively participates as a Committee Member of the Inter-Pacific Bar Association and the Hong Kong Corporate Counsel Association. Ir To is also involved in a variety of Boards and Companies ranging from Engineering, IT, and Research and Development.
- In 2001 Ir To was the youngest Director to be awarded Director of the Year Award in Hong Kong and in 2007 he was named as a Young Global Leader by the World Economic Forum.

Secretary of the Joint Mediation Helpline Office Ltd., Chairperson of the Special Committee of Arbitration and Dispute Resolution of the Hong Kong Bar Association and the President of the Hong Kong Institute of Arbitrators.
