During his 30-year career in the medical profession, Dr. Dai has specialised in geriatric, rehabilitation and pulmonary medicine. He has been the Consultant Geriatrician in the Department of Medicine at Prince of Wales Hospital, Hong Kong, since 2002, and he holds honorary teaching positions at the Chinese University of Hong Kong and Hong Kong University. Besides, he serves as the Hon Secretary of the Hong Kong Alzheimer's Disease Association, and he is its Immediate Past President.

Mr. Chan is a practicing barrister with Chambers of Ronny Wong, S.C., and an accredited general mediator of the Hong Kong International Arbitration Centre (HKIAC).

On the litigation side, he represents clients in a vast array of adversarial matters which focus mainly on civil litigation involving various disputes over, e.g., land/property, intellectual property (IP), employment, and company matters. He also regularly acts as an advocate in mediation.

Also, he conducts numerous mediations involving an element of, e.g., multi-story building, personal injuries, IP, directors/shareholders, siblings/family, trading, defamation, discrimination, and NGOs. He also delivers mediation talks regularly to a broad spectrum of organisations and institutions; frequently, he is invited to act as a mediation coach, or an assessor for the HKIAC's accreditation of general mediators. And, he has written articles on mediation in leading publications.

He sits on both the HK Bar Association's Special Committee on ADR and the HK Mediation Council (HKMC) of HKIAC, and is chairperson of the General Mediation Interest Group of HKMC.
